

CASTER INSTALLATION DECORA® & UCP PANEL REMOVAL

CASTER INSTALLATION

TOOLS REQUIRED: 1/2" wrench

- Install Locking Casters in the front of the rack. Locking Caster indicated by lever. Front of rack indicated by vents.
- 1) Assemble as shown. Install all nuts and bolts before final tightening.






CAUTION TIPPING HAZZARD: Mount 1/2 of equipment weight in lower 1/3 of the rack

UCP (UNIVERSAL CONNECTOR PANEL) REMOVAL

- 1) Gently hit the center of knockout with a rubber mallet to remove panel.
- 2) Install UCP panel using customer supplied hardware.








DECORA® PANEL REMOVAL

1) Remove Decora® panel by pushing on Plastic Rivets from the inside of the rack.

2) Remove Plastic Rivets and Decora® panel.
