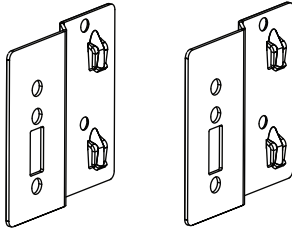

TOOLS REQUIRED

- 1/4" Hex driver and extension for torx bit

HARDWARE/ITEMS SUPPLIED



Accessory Brackets (Qty 2)



Torx Head Accessory Bracket Screws
6-32 x 5/16"
(Qty 4)

INSTALLATION

- 1) Select location for accessory mounting brackets.
- 2) Insert accessory mounting brackets as shown and secure to rack with (1) Torx head 6-32 x 5/16" screw per bracket. **(FIGURE A)**

NOTE: Mounting brackets can be installed on opposite side by engaging brackets upwards.

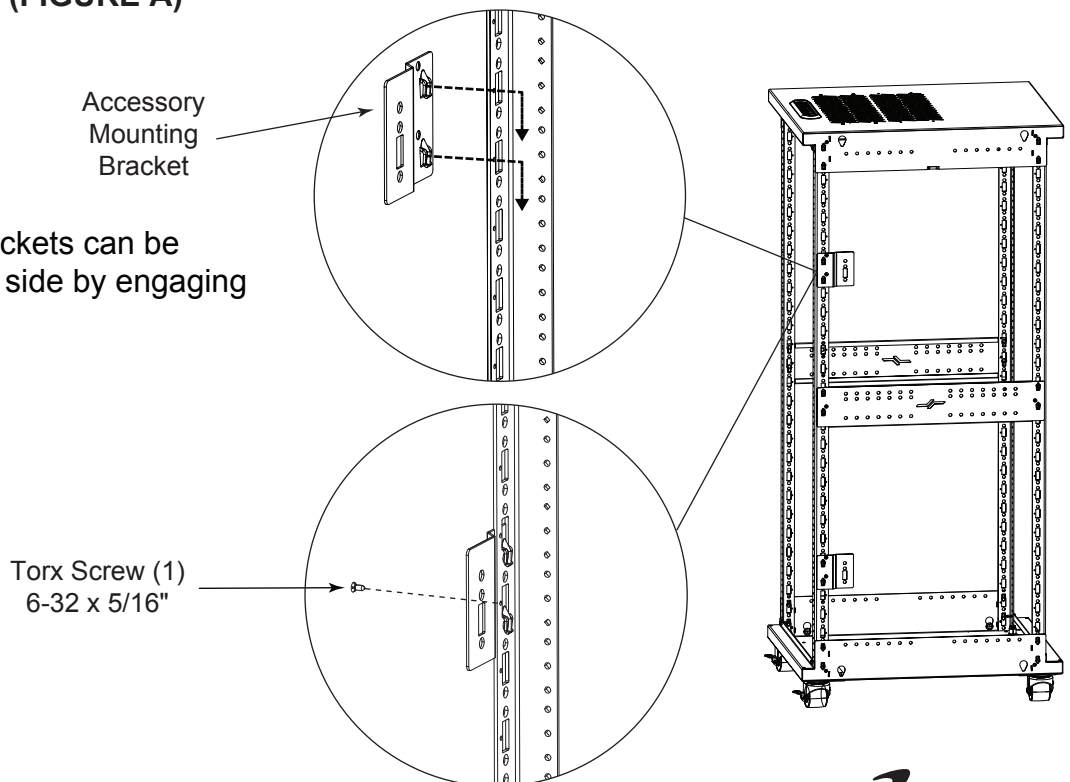
